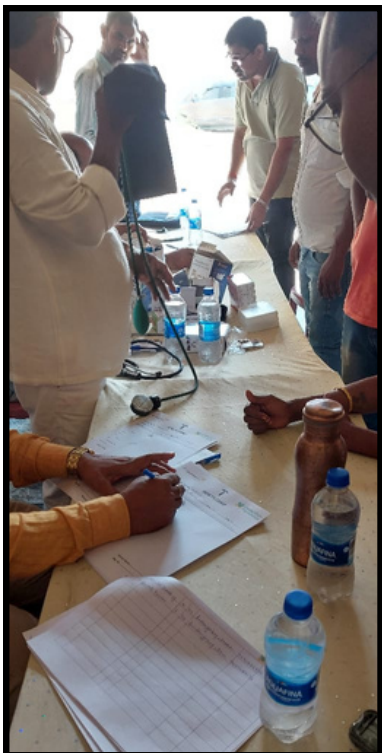

Free Medical Support Camp
